It is agreed that this is a conditional sale, and that until said appliances are fully paid for they are to remain your property with full title, ownership and right of possession resting in you. In the event of the non-payment of any of said installments at the times above specified or of the sale or incumbrance or removal of said appliances from my said address without your written consent, you shall have the right to immediately enter my said premises, retake possession of said appliances, and shall be entitled to retain as rental for the time I have had said appliances, all payments theretofore made by me under this agreement. Said appliances hereby purchased, are and shall remain personal property regardless of the manner of their use or attachment, and I shall be responsible for their loss or damage by fire, theft or other cause.

It is agreed that, should this contract provide for the installation of the appliance or appliances named herein and for the cost of such installation be borne by the seller, the necessary wiring and/or piping, when installed, will be maintained by me. You are relieved of responsibility for wiring and/or piping work done by others than your employees.

Receipt of a copy of this contract is hereby acknowledged. This becomes binding upon seller only when purchase is approved for credit.

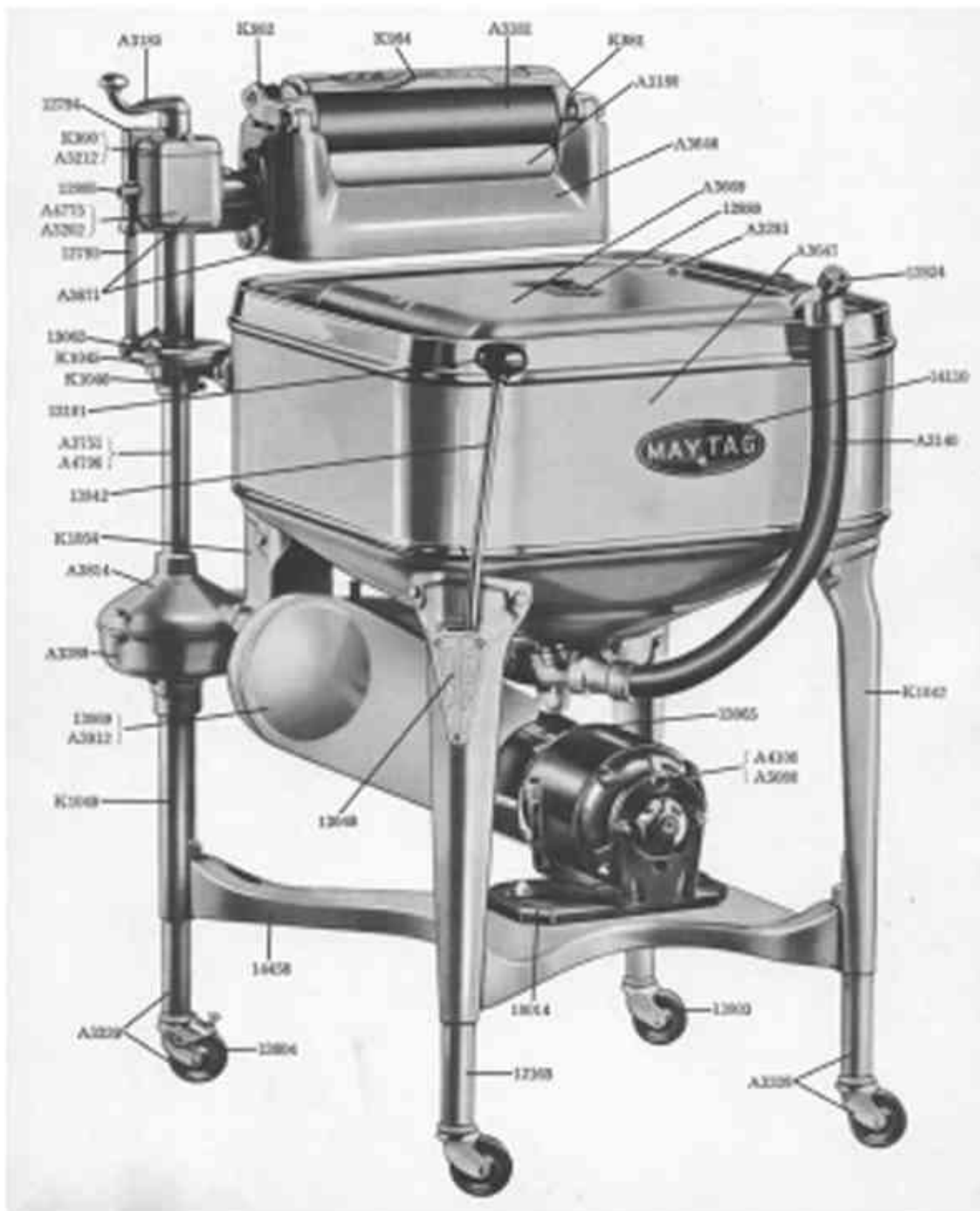
