Depositions of witnesses taken in the above entitled cause before Wm. A.Lewis, Circuit Court Commissioner for the County of Osceola, at his office in the village of Evart, said County, on the 25th day of April, 1878.

At 9 o'clock A.M. of said day Complainant appeared by her Solicitors, Beardsley and Judkins. Defendant also appeared by his Solicitors, Green and Lafler.

A witness produced and sworn on behalf of the Complainant said; Eliza Parker, a witness produced and sworn on behalf of the Complainant said: My full name is Eliza Jane Parker. I reside at Blackmar; have been staying the last 4 months at Mr. Blue's in Orient township. I know Mr. and Mrs. Brown, the Complainant and Defendant, have known them since the 8th day of last Nov. Have seen Mrs. Brown but three times since that time, but Mr. Brown worked at Mr. Blue's 3 or 4 months after the 8th of Nov.

Mrs. Brown was at home I suppose all this time while I worked at Blue's. I heard Deft., say that he never would live with Compl't, if he had a bill from her he would marry some woman back of Big Lake in less than 10 days. Heard him say while I lived at Blue's that he would go home and shoot Compl't. or tramp her brains out and burn the house down. Said he had a great mind to kick her out of Blue's house when he came and saw her there. Said he was going to the house that night and would do some damage, but I think he did not go. This conversation was addressed to myself and Mrs. Blue.

He was generaly, in his conversation he was running Compl't. down and abusing her. Heard him say he would never do another hands turn to support her and or her family. During the time he was at Blue's he was able to talk and run around but whether able to work I couldn't say, was a strong able bodied man as far as I knew. I guess rambling around doing nothing was his principal business. Mrs. Blue told me that Mrs. Brown, Compl't., worked for her before I went there, and she Compl't.worked at Mrs. Loyd 2 or 3 weeks while I worked at Blue's. Mr. Brown, Defendant has not been at home during the last 5 months. He told me he went to Compl't. and cut some trees down and broke the door in. I know nothing about Deft. drinking.

Cross examined said: He Deft. commenced talking about Compl't. without any one mentioning her name, he brought the subject up himself.

Bird Delamarter, a witness produced and sworn on behalf of Coml't said; I reside at Grient in this county, have lived there about 9 years, am acquainted with Hosea Brown Deft. have known him 13 years. Compl't. is my mother. Have lived a part of the time with Compl't. and Def't. Have lived at home but little of the time for the last 8 or 10 years, I made that my head quarters during that time, had my washing done there. During the last 2 years Def't. has not supported Compl't. to any extent scarcely and has been running about from one place to another, shiftless not supporting his family, all the time. Has been an able bodied man able to support his family, and during the same time Mrs. Brown Compl't. has by indrustry and economy supported herself and family. She has in her family now 3 children and she helps support all of them.

During the last 2 years Def't. has been very quarrelsome and abusive to my mother and her children. During that time she has been complled to work out more or less to support her family. Def't. during this time has been intoxicated quite frequently and is in the habit of getting drunk.

At this time he is absent from home, has gone to no one knows where. He has always been making threats to kill the children, about 5 years ago threatened to take my d--d heart out. He is a very quarrelsome overbearing disposition. Compl't. has lived in this county the last 9 years and is now a resident of this county. I heard Def't. say he would never live with Compl't. and would not support her, heard this within the last two years.

During this time he has come to Compl't. house only occasionally and when he did come, came to quarrel with Compl't. and would not stay or support the family. He Def't. is about 60 years old. Compl't. has all of this time been a good and faithful wife and has done all she could to manage with her household affairs. Cross examined said; Mr. Brown threatened to do violence to my body 2 or 3 times. Was about 14 years old when he first did so. He gave me a good many threshings. Have seen Def't. under the influence of liquor. It was not altogether on those occasions that he threatened me. He, Def't., has managed the farm the last 5 years till within the last year. About 20 acres of the farm is improved. He, Def't., ran over the country and spent the proceeds of the farm for himself, he squandered them. He has one cow on the place the proceeds of her were sold for money to purchase groceries with and used in the family.

Bird Delamarter.

John Blue, a witness produced and sworn on behalf of Complainant said: I reside at Orient in this Co., have lived there since June 1876. I know Compl't and def't., became personally acquainted with them last summer. Since I have known them Def't. has not been at home supporting his family, he has been running about from one place to another doing nothing for his family. He is a strong ablebodied man able to support his wife and children. He is now absent from this county at some unknown Since I have known him he has been in the habit of slandering and abusing his wife. Have heard him say she was not worthy of doing anything for. He said in March or April, 78, that he had come back from Ludington to fight the Delamarters, meaning his wife's family, that he came away from New York to save his wife Compl't. from going to States Prison.

He got some money of me under false pretenses and told me this story. I told him he ought not to talk so about his wife, I know her to be a nice woman. He said if I knew her as well as I did I would not say so. She is a good industrious woman, a good housekeeper. She worked for me.

Def't. is a man of very quarrelsome disposition, inclined to scandal-

ize his wife.

I live about two miles from Compl't. I heard him say he would not live with her, he wanted to get a bill from her, wanted to get married. Said this last December. Since I have lived there Brown, Def't. has been away from home a great deal and when he came home he scandalized his wife and quarreled with his neighbors.

He has the reputation of being a drinking man, his breath smelt very

strong whenever I saw him.

Mrs. Brown Compl't. worked some for me during the last six months, six weeks or two manths. She used the money she got of me to support her

family and carry on her farm.

He Def't. has the reputation of being overbearing, quarrelsome and abusive to his family. Def't. worked for me from the 7 of Nov. 1877 to January 5, 1878, the proceeds of this labor he squandered. When he worked for me he said he would not support his family, would not give them a thing.

Cross examined said:

I have seen and talked with Def't. a little since August 1876. When I first knew him I suppose he lived on his farm. He said he could not live with his wife and children, he blamed the family.

From my acquaintance with him I consider him a sane man, I think

his ailing is pure cussedness and ugliness.

I have heard him say he worked hard clearing the place off. When he worked for me I was in the woods. He was two months cutting 18 cords of wood. He is a kind of lazy good for nothing fellow.

John A. Clapp, a witness produced on behalf of Compl'6. said: I reside in Sylvan town this County, have 9 years.

Know parties to this suit, have 9 years. I live in a mile and a

quarter of them.

During the last two years Def't. has been away from home most of the time and Mrs. Brown and the children have supported themselves.

He is a stout able bodied man. he is a man who likes to run around much and do much talking about his wife and children. Last June he said to me, I am going to leave my wife and will never live with her again. He went away and came back. Said he would never support her again for all time to come. He has not since that time been back to help support them.

Mrs. Brown Compl't. has always had the name of being a very saving

and ind fustrious woman. I have heard of her working out frequently.

It is the general reputation of Def't. that he is very quarrelsome and abusive to his family. He was in the habit of drinking. Have seen him drunk often, he was then inclined to be cross and was inclined to slander his wife and children. I have heard him do so.

He told me after he came back from Ludington this spring that he never intended to support his wife again. Intended to fight her and the

children.

Cross examined:

Do not think Mr. Brown Def't. did his share in providing for the family. He improved most of his farm four or five years ago. Of late seemed to forget it.

When Brown was drunk I had a good time with him, laughing at him. Said he couldn't live with the family. Said he and the woman could get along well enough, but the devilish children, he couldn't get along with.

There is a farm amongst them. I don't know who owns it. Heard Brown Def't. say that her money went into the farm and she ought to have a 40.

Mr. Brown Def't. and self never had difficulty. He hauled off the wheat raised on the farm. Said he used it to go to Pennsylvania with. Don't know whether he went. I don't know that he supplied his family well the last two or three years, think he did not.

George Delamarter, a witness produced and sworn on behalf of Complit. said:

I reside in the town of Orient, Osceola Co. Compl't. is my mother. Have resided in Orient the last nine or ten years and have been at the home of Compl't. quite frequently the last nine or ten years. During that time Mr. Brown Def't. has been very quarrelsome and abusive to my mother and has neglected to support the family. Has threatened to injure mother and the children, talked of roasting my brother Bird, this was about seven years ago. He has beat and pounded the children Unmercifully, have heard him frequently threaten to put my mother out doors without any provocation on her part.

The last two or three years he has assisted very little toward the support of the family. Mother and self have worked out much of the time to support them. For the last two years he has refused to support Compl't. and has now left and does nothing toward her support. Mother has always been kind to Def't., tried to induce him by kind treatment to do better. Whenever he comes into the neighborhood of Compl't. he slanders, scandalizes and abuses her.

She is indrustrious economical and tries to keep peace in the family. Def't. has absconded from the county and gone to parts unknown. There are three children with the family and Compl't. at home. Mother is poor, and means of support but from her and the children's labor.

I have heard Def't. say several times that he never intended to live with Compl't. again. For the past year he Def't. has been said to carry a paper around purporting to be a divorce from Compl't. He exhibited the same to the neighbors and tantalized her Compl't. with it. Have heard Def't. talk indecently to my mother.

He is an able bodied man able to earn fair wages. He is also a wandering, shiftless character and does but little to support his family. The money he gets, he squanders upon himself.

Cross examined:

Have heard him swear at and abuse my mother. I think him sane. He had a brush heap on fire on which he said he would roast my brother, he was not then drunk. He once threatened to cut my heart out.

Def't. cleared 15 and we cleared 5 acres of the farm. Have known Brown Def't. to lie frequently.

Redirect:

My mother owns the 40 acres on which she lives.

Cross examined:

I think his actions were the result of pure develtry. He seems to think that when tired with living with one woman, he could go and live with another, appears to like vanity.

George W. Delamarter, a witness, produced and sworn on behalf of Compl't. said:

I reside in Orient township. Know Def't. and Compl't. who is my sister. Have lived near them seven years, the first three years, two

miles, the last four years, one half mile from their home.

Def't. is a very quarrelsome overbearing disposition. During this time he was often drunk. During the last two years Compl't. has had to do much toward her own support. The last year he has been running around from one place to another, and doing very little to support his family.

Compl't. is industrious and supports her family, is a kind good

woman. Def't. when about home scandalizes and abuses his family.

During the last year she Compl't. has worked out to support herself

and family. She worked for Mr. Blue and for me.

He has threatened to leave Compl't. and that he would not live with or support her. I have been there to their home frequently. He almost always said disagreeable and unpleasant things to Compl't. and was abusive. Some time ago in March 77, he Def't. came to Compl't. house and threatened to cut his own throat, said he could not stand such treatment. I was there at the time. He was abusive of Compl't. Contradicted and threw up about her being a member of the church.

They were married on the third dat of July 1865, in the township of Romulus, Seneca County, New York, by Joseph Wyckoff, Justice of the Peace. So far as I know since the marriage she has always done all she could to keep peace in the family and he has abused her and the children all

of this time.

I understand there was now a criminal charge against him for obtaining goods under false pretenses and he has skipped and left the country.

He claimed to me that he had a petition to the court for a divorce and all that was necessary was for her to sign it. He told me it was signed by Beardsley and Burch. He Def't. has not lived at home of Compl't. any or any amount for two years and all or most of the money he gets he squanders.

Cross examination:

I don't know but Def't. has run up large bills at store for use of his family. Am not cognizant of the fach that he has been harassed by creditors. I know he has done some work the proceeds he used mostly for himself individually. I know other that have worked out both man and wife. Knowing the circumstances of life the past few years I consider him sane.

Have heard him use vile epithets toward his wife. His farm was a homestead. He Def't. entered it. Brown Def't. deeded the 40 acres now occupied by Compl't. to me and I deeded it to her, there was no money passed in consideration. He deeded it to her if she would sign the deed for the other 40.

Redirect:

Compl't. paid the cost of advertising the land and paid for the cow out of her own money.

Myself and mother have had to work out for support. Def't for 2 years has been very cruel to Comp. and to children, abusing us all, calling us all kinds, of names, have heard him threaten to beat the boys, my two brothers, without provocation on their part. He Def't. has been running around from place to place doing very little toward their support. He has been very abusive, has threatened to leave my mother. Said he would never live with her again or support her. He has now gone we know not where. Mother has always been kind to him, Def't. He is an able bodied man able to support his family. Frequently during the last 2 years, came home drunk and was very abusive . He circulates slanderous stories of Comp. when in the neighborhood but does not come and do anything toward our support.

Cross examined:

Have never seen Def't. strike Comp. but have heard him talk abusingly to her. Have seen him sick. Mother then took good care of him. He never complained of the treatment she gave him when sick. Never saw him come home with packages of clothing. He came home last summer and took his things out of the house and swore he would never darken the door again. I went to prayer meeting with him and he came home and swore at us. He has always been so ugly. Think he has struck me once. He had the handspike, was going to knock me down. Have seen him intoxicated, was no kinder than when sober. Nothing would soften him. Don't think he is at all inclined to insane.

He wanted to sell me a chain, said he wanted to leave the old woman and wanted to sell every damned thing that he had and not let them have it. I know he has been running around considerable. Have heard Def't. say Comp. was not a very good woman and called her daughter a prostitute or words to that effect. I saw a paper he showed me, it. He called it a petition to the court. It has Burch and Beardsley's names signed to it, though not signed by them. It was neither Burch or Beardsley's writing. Claimed that if Comp. would sign it, it would divorce them. He Def't. talks about and scandalizes his wife and family in the neighborhood. Is a reckless fellow, seems to care for no one.

The report is that he has absconded. I am satisfied that he is gone. Comp's. reputation is good in every respect so far as I know and the daughter's also the very best. Def't. is a strong able bodied man, I judge. Have known the parties to this suit 4 years, have seen Mr. Brown since 71 and 72. On this 20th day of Jan.1905, personally appeared before me, a Notary Public within and for the county and state aforesaid, Mrs. Esther M. Brown, widow of Jacob Delamarter, aged 73 years, a resident of city of Cheboygan, County of Cheboygan, state of Michigan, who being duly sworn according to law, makes the following declaration for the purpose of having her name placed on the pension roll under provisions of the act of March 3, 1901 and Feb. 28,1903, amending section 4708, Revised Statutes.

That she was formerly the widow of Jacob Delamarter, who died on or about July 3,1863, by reason of wounds or injury received or desease contracted while serving as private in Co. H 141 Pa. in the war of the Rebellion. That she was his lawful wife during the period of his service in said war, having been married to him Oct. 2,1851, and that she remained his lawful wife to the date of his death. That said soldier was not in the

military or naval service of the United States prior to
