

## Will of Edward Heath (1525-1593)

Edward Heath was buried on 3/8/1592/93 at Ware, Hertfordshire, England. His estate was probated on 3/23/1592/93.

"...unto Alyce my wyff xl a yere duryng her lyff, And her dwellyng in my howse, that ys to saye the chamber that nowe useth to lie yn wthall moveables of household stuff nowe thereyn, the kytchen & the Buttrye, wth ffree egressse ingresse & regresse into the same & easyments in the backsyde during her naturall lyff/And A table with ffourme in the hall/Provided, alwayes and my wyll ys that two of my daughters Elen & Kateryn shall have all the aforeseid household Stuff after my wyffs decease equallie to be divided betwene them by the Discrecon of my sonn Wilm/ ...to my said two daughters Elen & Dateryn xx s a pece to be payed thme At the daye of their Maryage/ ...to Johan my daughter vj s viij d to be payed to her witin one yere after my decease/...to my daughter Johan her sonn xiiij s viij d to be payd at his age of xv yeres...to Elizabeth my daughter vj s viij d within one yere after my decease...to eyter of her children John and Margaret vj s viij d a pece At their Age of xv yeres... to Thomas my sonn xl s whereof xx s to be payd within one yere after my decease And the other xx s within the next yere then next ffolowyng... to my sonn John xx s to be paid within one yere next after my decease... to my daughter Margaretts children now Alyve v s a pece to be payd At their Age of xv years after my decease ... to my sonn Wilm All that my nowe dwelling house withall the edifice yards gardens wthall the Appurtenances thereunto belongyng scituat in Lytle Amwell in the countie of Hertf to hym & his heyres for ever, And all the residue of my goods & moveables unbequeathed ... to my sonne Wilm his children nowe Alyve vj s viij d A pece At their Age of xvij yeres/ A;; wch severall somes of money to be payd by my sonn Wilem whom I do ordeyne & make my sole Executor of this my last Wyll & Testament."

Written in the left margin

"Itm I geve unto my sonn Robt xl s where of xx s within one yere after my decease and the other xx s within the yere then ffolowyng And all my apparell/ Itm I geve unto ererie of my sonn Robert his children v s A pece to be payd to them at the Age of vx Age. Md that Robt his gyft was entred before the ensealyng herof."
